Fortum will continue its contribution in 2025 at € 27,500 (as in 2024). Ringhals, Forsmark and OKG continue their contributions of € 13,000 each in 2025 (as in 2024). IFE will continue its contribution of NOK 120,000 (as in 2024) in 2025.
4	Financial status report November 2024.	FP presented the present financial situation, which is as planned. The reserve level is ca. 0,51 MDKK.

Generally the NKS-R projects are progressing well: FEMMA, INSOLE, POSEIDON, REPOUSSES, Nordic-SMART, CURES, PAS-SMR and STATUS. Two reports from 2023 are pending: The final report from DATA4DECOM is nearly finished. Publication in December?

The final report from TRIO is waiting for article submission. The article was rejected once.
